

New Sudbury Centre 2016 We Have That Contest

Rules and Regulations

ENTRY PERIOD:

- (a) The Contest is brought to you by New Sudbury Centre (the “**Contest Sponsor**”).
- (b) The Contest entry period (the “**Entry Period**”) starts at 9:00 am on Monday, September 19th 2016 and continues until Friday, October 28th, 2016 at 6:00 pm. All times are Eastern.

ELIGIBILITY:

This contest is intended for residents of Ontario only and will be interpreted according to Canadian Law.
